Description

Practices in rural South Carolina have unique needs. The primary care workforce is dwindling despite the ever growing needs of South Carolinians as they age and the rate of chronic illness continues to rise. Although the vast majority of our state is classified as rural, fewer health care professionals and primary care physicians choose to practice in these areas. This training seeks to provide necessary education and best practices related to interprofessional health services in rural areas to enhance service delivery in these rural settings.
